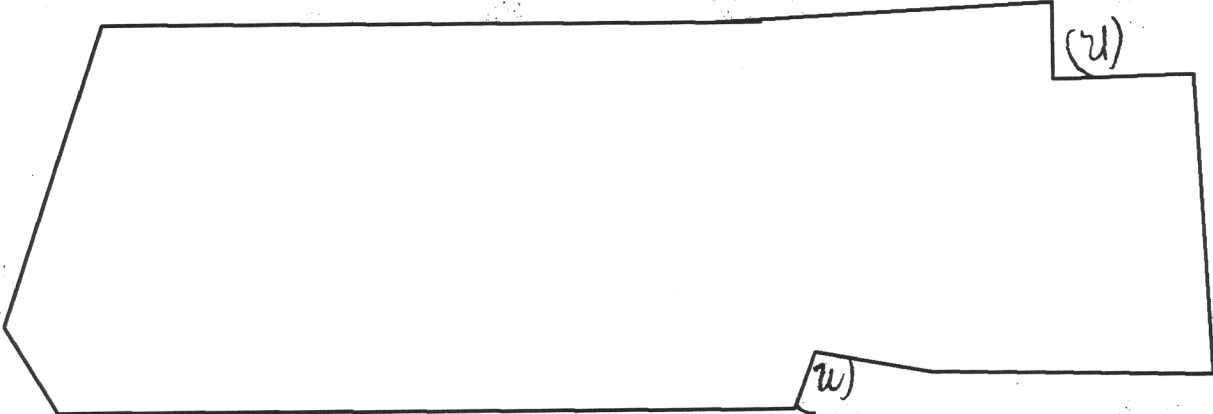

LLOYD BROWN, District Organizer of Western Pennsylvania, is a veteran of the Y.C.L. In August, when the steel drive began, Subject went down to Pittsburgh as the representative of the National Committee of the League. Subject has been in the Y.C.L. longer than any other Negro member. He joined in 1929, in his native town of St. Paul, Minnesota, worked in New Haven, Youngstown, Cleveland, and New York; was also the first district organizer of New Jersey and one of a long list of editors of the "Young Worker". Subject has left many good friends in the various places in which he has worked. His favorite pastime is dancing, and it is rumored that he can "shake a mean hoof" on the dance floor, lays claim to be a shark at shooting pool, a claim hotly disputed in many and diverse quarters, proudest possession is the watch the New York Y.C.L. presented him as a farewell gift. In a letter from the Bureau to Assistant Director E. J. CONNELLEY, dated August 21, 1941, there reads as follows:

"For your information and investigative attention, the following are the known Officers of the Young Communist League: (u)

LLOYD BROWN - State Secretary,
Western Pennsylvania.

On November 6, 1941, the Writer contacted the residence at 3047 Centre Avenue. It was noted that the name "BROWN" appeared on the front door as being in Flat #1. At that time, the Writer could not get any response to Mr. BROWN's doorbell. It was noted that there was also the name of [redacted] in [redacted]. The Writer rang this bell and a colored man came to the door who stated that his name was [redacted]. The Writer asked [redacted] if BROWN lived there. [redacted] stated that BROWN did live [redacted] and then the Writer asked [redacted] if BROWN was employed by the National Youth Administration. To this question, [redacted] stated, "Yes, BROWN is a Communist". The Writer then endeavored to question [redacted] further in regard to the statement that BROWN was a Communist, and [redacted] stated that he was sorry that he said that because he did not like to go into a man's political party. As the Writer was leaving this residence, he noticed that a colored man, in company with a colored woman and a small child, were coming up the steps and [redacted] the description of LLOYD LOUIS BROWN. (u)

From this investigation, it is reasonable to believe that LLOYD LOUIS BROWN is presently residing at 3047 Centre Avenue, Pittsburgh, Pa. (u)

MEMORANDUM FOR
HUGH B. COX, ASSISTANT ATTORNEY GENERAL
AND
J. EDGAR HOOVER, DIRECTOR
FEDERAL BUREAU OF INVESTIGATION

I refer to [redacted] memorandum to me dated June 28, 1943, which reviews the history, development, and meaning of the Special Case work and of the danger classifications that were made as a part of that work. b7C

After full re-consideration of these individual danger classifications, I am satisfied that they serve no useful purpose. The detention of alien enemies is being dealt with under the procedures established by the Alien Enemy Control Unit. The Special Case procedure has been found to be valueless and is not used in that connection. There is no statutory authorization or other present justification for keeping a "custodial detention" list of citizens. The Department fulfills its proper functions by investigating the activities of persons who may have violated the law. It is not aided in this work by classifying persons as to dangerousness.

Apart from these general considerations, it is now clear to me that this classification system is inherently unreliable. The evidence used for the purpose of making the classifications was inadequate; the standards applied to the evidence for the purpose of making the classifications were defective; and finally, the notion that it is possible to make a valid determination as to how dangerous a person is in the abstract and without reference to time, environment, and other relevant circumstances, is impractical, unwise, and dangerous.

For the foregoing reasons I am satisfied that the adoption of this classification system was a mistake that should be rectified for the future. Accordingly, I direct that the classifications heretofore made should not be regarded as classifications of dangerousness or as a

determination of fact in any sense. In the future, they should not be used for any purpose whatsoever. Questions raised as to the status or activities of a particular person should be disposed of by consideration of all available information, but without reference to any classification heretofore made.

A copy of this memorandum should be placed in the file of each person who has hitherto been given a classification. In addition, each card upon which a classification appears should be stamped with the following language: || ✓

"THIS CLASSIFICATION IS UNRELIABLE. IT IS
HEREBY CANCELLED, AND SHOULD NOT BE USED
AS A DETERMINATION OF DANGEROUSNESS OR OF
ANY OTHER FACT. (SEE MEMORANDUM OF JULY 16,

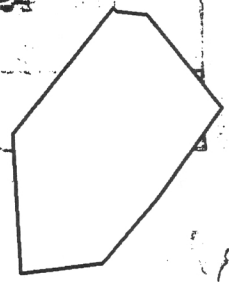

On 7/1/60, in the vicinity of 43rd St., and Eighth Avenue, NYC, LLOYD BROWN was approached by SA [redacted] for the purpose of conducting an interview under outstanding instructions relating to the Toplev Program. SA [redacted] observed from a discreet distance.

When approached, BROWN acknowledge his identity and appeared somewhat startled when the identity of the interviewing Agent was revealed. Following a brief preliminary conversation BROWN relaxed and smiling broadly stated that he had no desire whatsoever to discuss any matter with the FBI. Further attempts to engage him in conversation, as he continued walking toward his place of employment, were unsuccessful. Because a light rain had started to fall it was suggested that he pause under a hotel marquee. BROWN refused. The interview was terminated. (u)

Although BROWN was not unfriendly or hostile he nevertheless gave no indication that he might cooperate with the Bureau. Therefore, no recontact is anticipated at this time. The results of this interview will be included in the next annual report. (u)

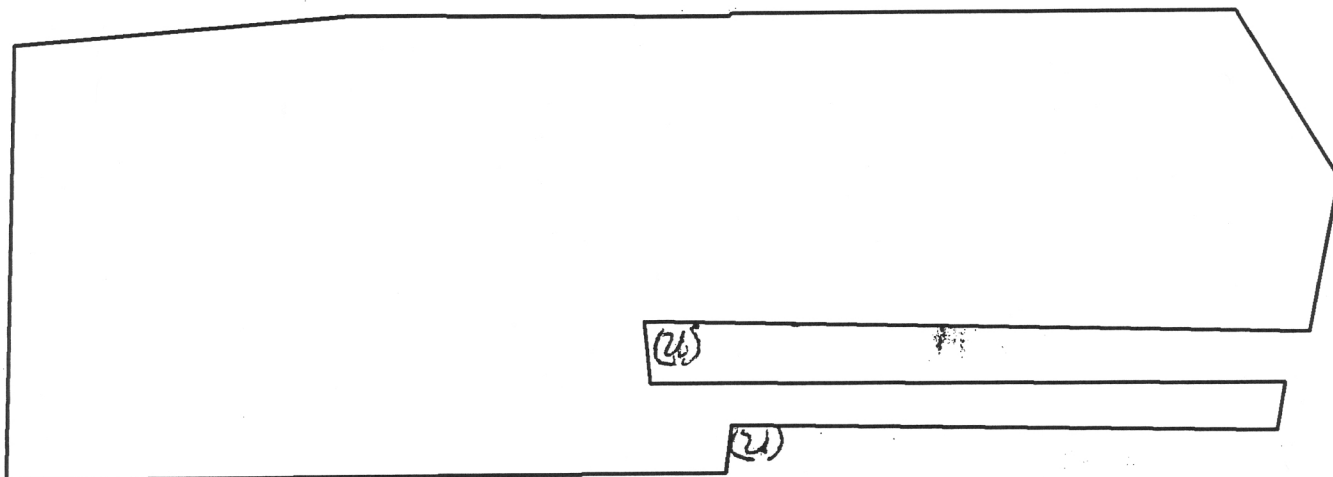

Subject's first known association with the Communist party, according to the files of the Pittsburgh Field Division is a notation in confidential source No. [] quoting an article in the "Daily Worker" on October 3, 1933, wherein describing an anti-war Congress held by the Communist party in St. Nicholas Arena, New York City, there is as follows: (u)

"Lloyd Brown of the Young Communist League electrified the nearly 3000 delegates and 2000 spectators by his declaration that the militant youth of America will follow the path of the heroic Communist Party leader of youth, KARL LIEBKNECHT, in unyielding struggle against the war makers. BROWN was one of three youth speakers." (u)

In the 1937 yearbook of the Young Communist League, subject was listed as the district organizer for the Western District of Pennsylvania, and following is an article describing the subject in that periodical. (u)

"LLOYD BROWN, District Organizer of Western Pennsylvania, is a veteran Y.C.L. 'er. In August, when the steel drive began, LLOYD went down to Pittsburgh as the representative of the National Committee of the League. LLOYD has been in the YCL longer than any other Negro member. He joined in 1929, in his native town of St. Paul, Minnesota, worked in New Haven, Youngstown, Cleveland, and New York; was also the first district organizer of New Jersey and one of a long list of editors of the "Young Worker". (u)

"LLOYD has left many good friends in the various places in which he has worked. His favorite pastime is dancing and it is rumored that he can shake a mean hoof on the dance floor, lays claim to being a shark at shooting pool, a claim hotly disputed in many and divers quarters..proudest possession is the watch the New York Y.C.L.'ers presented him as a farewell gift."

According to confidential source of information No. [] the leaders of the Communist Party of Western Pennsylvania were in a group known as the "District Committee". Subject was a member of this committee in 1939. ^{March 1941} The source indicates that he previously had been a member of the Speaker's Committee since 1938. In a [] dated February 2, 1941, the subject is described as a figure in the party, and confidential informants [] and [] whose identify is known to the Bureau, advised that early in 1941, the subject was a member of the Communist Party. (u)

Prior to the election of 1940, the Communist nominating petition was circulated in the Pittsburgh area to secure the signatures necessary to place the party candidates on the ballot. According to the testimony at his trial, the subject in June, 1940, circulated petitions of the Communist party falsely reporting to prosperous figures that they were petitions of the Democratic Party. Because of this he was indicted in the June term of the Grand Jury, under indictment #519, charging conspiracy, and indictments #596 and #597 charging perjury. After the trial on August 30, 1940, the subject was found guilty, and after a motion for a new trial had been refused, on March 18, 1941, he was sentenced on each of the perjury charges, the sentence to run concurrently, to serve four months in Allegheny County Jail and to pay a fine of \$200 on the conspiracy charge. The subject served his term and paid his fine. (u)

In an article appearing in the Pittsburgh Sun Telegraph on April 21, 1941, the subject was described as instructing his seventeen fellow Communist party members, who were in the Allegheny County Jail with him, serving sentences which were similar to that of the subject, in American history and English. It was reported that BROWN is a negro ex-serviceman and represented the "United Veterans for Equality" and pledged his and his buddies fight for a people's victory on the home front. It was reported that this statement by BROWN was made at a mass meeting at the Golden Gate Ballroom, 142nd Street and Lenox Avenue, on the occasion of the "Smash the Filibuster" Rally. Other principal speakers at this event were VITO MARCANTONIO and Congressman ADAM CLAYTON POWELL. (u)

In the Daily Worker of April 6, 1946, the following article concerning LLOYD LOUIS BROWN appeared: (u)

Parts of this article are quoted below: (u)

"The Readers Digest can bump along its evil way isolated in Westchester and the Luce publications can come out of a penthouse but a Marxist magazine like 'New Masses' can only come out of the people." "That's why in changing to new format and a broader cultural content, New Masses is inviting its readers and friends to a conference to discuss the change. It was announced that the conference was to be held at the Paramount Restaurant, 138 West 43 Street, on April 13 at 2 P.M. This article continued by stating that the New Masses magazine would follow a Marxian policy and would attempt to bring to the people information prepared by the working class. It was announced that LLOYD LOUIS BROWN had been appointed as a new editor to the staff of New Masses. (u)

In the daily worker of April 9, 1946, there appeared a half page advertisement announcing that 300 Communist Party clubs would hold a special meeting that week. The following headline appeared in this advertisement: "Hear: Outstanding Leaders of the Communist Party Speak On All Branches on 'The Struggle for Peace and Building the Communist Party'." (u)

LLOYD LOUIS BROWN was listed as a speaker for this event from New York County. (u)

On October 5, 1946, there appeared in the "People's Voice" an article which carried the following headline: "Writers Discuss Anti-Fascist". It was announced that Contemporary Writers had announced that week the theme for the general meeting and forum to be given at Malih Studios, 315 West 42nd Street at 8:30 P.M. (the date was omitted in the article but it was believed to be October 3, 1946). The theme for the forum was to be "The Negro in American Literature." LLOYD LOUIS BROWN was listed as a speaker. A brief summary concerning BROWN stated that he was Editor of the New Masses magazine and was a World War II veteran, having travelled widely in Europe as correspondent for Labor Press. (u)

In the Daily Worker on September 28, 1946, there appeared an advertisement announcing that LLOYD BROWN, Managing Editor on New Masses, would be speaker at the first Allerton Section, C.P. series of forums. It was announced that BROWN would speak on "New People's Democracy in Eastern Europe". The date of the forum was not given but was listed as Sunday at 8 P.M., the place was 2700 Olinville Avenue, Bronx, New York, and the admission was 25¢. (u)
