The records show her home address as 388 Chauncey Street, Brooklyn, New York, and she was born on November 21, 1910, in Baltimore, Maryland. [redacted] stated that the applicant was personally unknown to him, but that she was in good standing during her enrollment at Columbia University.

She stated that the applicant possessed tremendous integrity and was emotionally and mentally stable. She stated that the applicant enjoyed an excellent reputation and she has no question whatever concerning her loyalty to the United States.

[redacted] has no knowledge of the applicant's family, but has continued to have periodic contact with the applicant during recent years. She understands that the applicant has been most recently employed as a Consultant to the Equal Opportunity Commission, in Washington, D. C. She highly recommended the applicant for a position of trust and confidence.

On January 11, 1967, [redacted] Attorney, 299 Broadway, advised that he was not personally acquainted with the applicant.

On January 13, 1967, [redacted] Attorney, 408 West 145th Street, New York, New York, advised that he was a close friend of Mr. CARSON BAKER, now deceased. He stated that BAKER, at one time, had his law office at 225 Broadway, and [redacted] frequently visited the office where he met the applicant. He stated that the applicant impressed him as a very intellectual young woman who did marvelous research work. He advised that the applicant was a graduate of Howard University and was a very well-read person. [redacted] stated that he never worked directly with the applicant and is not certain as to the dates that she was associated with Mr. BAKER. He felt, however, that she worked for BAKER for at least one year. He advised that he never had any reason to question the applicant's loyalty to the United States, and recommended her for a position of trust and confidence.

NY 140-16717

On January 18, 1967, [redacted] Attorney, 30 Vesey Street, New York, New York, advised that he was formerly associated in the practice of law with Mr. CARSON BAKER, at 225 Broadway, New York, New York. He advised that BAKER is now deceased. [redacted] stated that the applicant was employed in BAKER's office, from about 1946 to 1950, and he became well-acquainted with her. He stated that the applicant was a very studious and open person, who was very sensitive to the issues of our time. Her employment with Mr. BAKER was in the nature of a law clerk and she did research tasks and handled minor cases for him. [redacted] stated that he does not know whether the applicant was ever admitted to the Bar. He stated that BAKER's office was located in Room 302, at 25 Broadway, New York, New York.

[redacted] stated that he has not seen the applicant for several years, but has no reason to question her loyalty to the United States, and based upon his past experiences with her, would recommend her for a position of trust and confidence with the United States Government.

On January 23, 1967, [redacted] New York, New York, advised that he formerly shared office space with the applicant, from about 1948 to 1956, when they practised law, at 6 Maiden Lane, New York City. He stated that he worked closely with the applicant and found her to be an honest, competent lawyer. He stated that she was very intelligent and excelled in doing research work. He advised that she was at one time, employed as an Assistant Attorney General by the State of California, and later served as a professor in the Law School operated by the Ghana Government.

During that time, [redacted] was also employed in Ghana and he had frequent contacts with the applicant there. She resided in a private residence furnished by the Ghana Government and lived by herself. The applicant frequently expressed to [redacted] her unhappiness about the lack of free speech in Ghana, and she was concerned regarding the obvious communist influences being exerted upon the country.

[redacted] stated that he would have absolutely no question regarding the applicant's loyalty to the United States and he would recommend her for a position of trust and confidence. He believes that the applicant was married at one time, but that the marriage has since been annulled.

[redacted] New York, New York, advised that she has been a resident at that address for many years, but could not recall the applicant. She stated that there has been an almost complete turnover of the tenants at that building in recent years and she could suggest no one else who might recall the applicant.

Maloff and Company, 3801 Broadway, New York, New York, advised that her firm manages the building at the captioned address; however, she has no records concerning tenants living at that address prior to 1950. The fellowship was given to the applicant in order to make the comparative study relating to law and public affairs, but the Fellowship was deferred for financial reasons until September 1, 1964. The fellowship was used for studying and writing on the roots of Negro problems in the United States, at Yale University. b7C

The records show that ANNA PAULINE MURRAY was employed as a switchboard operator and had been born in Baltimore, Maryland. This was also her first marriage and she was aged 20 at that time.

On January 11, 1967, IC [redacted] reviewed the records of the Bronx County Clerks Office, and was unable to locate any record of divorce for the applicant.

MISCELLANEOUS

Records Library of Congress (LOC), were reviewed by IC [redacted] on February 1, 1967, for book reviews and reports on publications and books authored by employee. The following book review was noted for publication "Proud Shoes," written by employee and published by Harper in 1956. b7C

"In a biography of her grandfather FITZGERALD, PAULI MURRAY presents a small part of the pattern of Negro culture in the U.S., for her grandfather was of Irish-African descent, a northern mulatto, one of the few Negro soldiers in the Union Army and a man who took it upon himself to come South after the Civil War to start schools for his 'newly freed' people in Durham, N.C. As such, this review of his life has importance in the history of desegregation, and the author muses of the many shades of meaning and the attitudes Negroes and Whites both hold and attribute to each other."

LOC records contain no other pertinent information regarding publications authored by employee.

IC [redacted] caused a search to be made of the files of the Naval Investigative Service Headquarters, and was advised on January 3, 1967, that the files contained no record for employee. b7C

IC [redacted] caused a search to be made of the files of The Credit Bureau, Inc., Washington, D.C., and was advised on February 1, 1967, that a satisfactory credit record was located for [redacted] sister of employee.

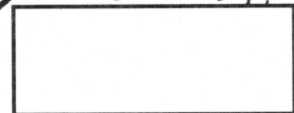
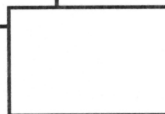

The purpose of this memorandum is to advise that a Security of Government Employees investigation was completed in connection with Pauli Murray in February, 1967, and the results furnished to the Civil Service Commission. The basis for our investigation was admissions by Murray that she had been a member of the Communist Party of America (Lovestonite group) and had been employed by other communist front organizations in the 1940's. The White House requested the results of our investigation March 7, 1967.

We have now learned that Murray was being considered for the position of General Counsel for the Equal Employment Opportunity Commission. On April 4, 1967, Stephen N. Shulman, Chairman of the Equal Employment Opportunity Commission, called at my office at which time he was interviewed by Section Chief William V. Cleveland and myself. Mr. Shulman stated that he had carefully reviewed information developed during the FBI investigation of Murray and wanted to discuss the feasibility of going ahead with her appointment in view of derogatory information contained in our reports. At the outset it was carefully explained to Mr. Shulman that the FBI is strictly an investigative agency and the facts contained in our investigative reports were for the assistance of the employing agency in making a decision regarding the person's suitability. Mr. Shulman was told that no recommendations for or against Murray would be made. Mr. Shulman indicated he understood this but hoped to obtain certain clarifying information.

BACKGROUND:

Murray, aged 56, a Negro, is well educated, holding B.A., LL.B., LL.M., and J.S.D. degrees. In addition to membership in the Communist Party of America in the 1930's and employment by a

CURRENT DEVELOPMENTS:

Mr. Shulman noted the persons interviewed during our investigation generally commented favorably concerning Murray and they wanted to know how to balance this fact with the fact that she had belonged to and worked for numerous communist organizations. He was advised that this was an adjudication problem which he would have to decide, taking into consideration such things as whether or not she had ever openly repudiated her former association with these organizations. Mr. Shulman then wanted to know about the various organizations for whom she was employed by or had been associated with up until 1948, and it was pointed out to him that each organization was fully documented at the end of the reports he had in his possession.

In summarizing, Mr. Shulman stated that his problem was to determine how not to give Murray the job as General Counsel since actually she had now been employed by the Government on a consultant basis for some eight months. He indicated, however, that he would challenge her on four items, namely: her affiliation with Communist Party organizations, the circumstances of her admission and release from Bellevue Hospital; her unconsummated marriage and lack of annulment, and her two arrests and jail sentence.
